JVC Distributor as shown in the column below("Distributor") warrants to the original purchaser that Distributor will be responsible for repairing or replacing any part of the purchased JVC product which proves defective due to improper material and/or workmanship subject to the terms and conditions as follows:

- 1. TERM OF WARRANTY(Valid from the date of purchase)
 - (1) No labour charge for 12 months.

- (2) Free replacement of parts for 12 months. However, parts used for replacement are warranted only for the remainder of the above warranty period.
- 2. THIS WARRANTY IS VALID ONLY WHEN:
 - (1) This JVC warranty certificate is completed in full and presented together with the original proof of purchase bearing the purchase date of product requiring service.
 - (2) The JVC product referred to herein is purchased from the Distributor and is delivered to and collected from a JVC Authorized Service Centre as listed below at the owner's risk and expense. (Home service is not covered.)
- 3. THIS WARRANTY PROVIDED BY DISTRIBUTOR DOES NOT COVER:
 - (1) Products which have been subject to abuse, accident, alteration, modification, tampering, negligence, misuse, faulty installation, lack of reasonable care, or if repaired or serviced by anyone other than a service facility authorized by Distributor to render such service, or if affixed to or used in combination with any items not provided with the products, or if the model or serial number has been altered, tampered with, defaced or removed.
 - (2) Initial installation, installation and removal from cabinets or mounting systems.
 - Operational adjustments covered in the Owner's Manual, normal maintenance, video and audio head cleaning.
 - (4) Damage that occurs in shipment, due to acts of God, and cosmetic damage.
 - (5) Signal reception problems and failures due to line power surge.
 - 6) User Removal Memory Devices/Video Heads, CCD Image Sensor, Cartridge, Stylus(Needles), Lamps and other consumable parts.
 - (7) Any defect or failure of built-in hard disc drive, under the judgment of Distributor, JVC authorized service center and/or JVC group company, that is caused by or resulted from any drop, impact, shock or the like given to built-in hard disc drive
 - (8) All kind of Accessories.
 - (9) Batteries.

- (10) Products used for commercial purposes, including, but not limited to rental.
- (11) Loss of data resultant from malfunction of hard drive or other data storage device.
